#### SUBCHAPTER 1. GENERAL PROVISIONS

### 13:56-1.1 Parking permit

(a) Except as hereinafter provided, the operator of a vehicle shall not park the vehicle in any parking area constructed, owned, and maintained in Trenton by the State of New Jersey, unless such vehicle is registered with, and a valid parking permit is issued by, the Department of Treasury, Division of Property Management and Construction.

(b) All State parking permits shall be hung from the rearview mirror with the serial number facing forward.

13:56-1.13 Entrances to parking areas

(a) All vehicles entering the State House Complex parking areas shall enter at the Barracks Street entrance at the intersection with Lafayette Boulevard.

(b) The entire State House Complex parking area, may be closed at anytime deemed necessary to provide security to the State House and buildings within the State House Complex parking area.

1. COMMENT: N.J.A.C. 13:75-4.10(b). The commenters request the agency to add the wording "including costs" after attorney fees at N.J.A.C. 13:75-4.10(b) for related legal expenses up to the maximum of \$10,000, which is understood to be the current practice of the Office. (1 and 3)

RESPONSE: The Office agrees to add the wording "including costs" after "attorney fee" at N.J.A.C. 13:75-4.10(b), as it is the current practice of the Office to pay these fees and similar language can be found at N.J.A.C. 13:75-4.10(a).

2. COMMENT: The commenter presents an issue regarding the availability of the attorney fee benefit for each separate approved claim filed by a victim involving the same offender without limitation. (1)
